## 1. Introduction

## 3. Information We May Collect

We may collect and process the following types of personal information:

- **Identification details** such as your name, title, and contact information (email address, phone number, postal address).
- **Professional details** such as your organisation, role, and investment or business interests.
- **Technical data** including your IP address, browser type, and information about how you use our website.
- **Correspondence data** such as information you provide when you contact us by email, phone, or through our website.

We do not intentionally collect special category data (e.g. health, political opinions, religious beliefs) or information relating to children.

## 4. How We Use Your Information

We may use your personal information for the following purposes:

- To respond to your enquiries or requests.

- To manage our business relationships and provide information about our services.
- To maintain and improve our website, security, and user experience.
- To comply with legal or regulatory obligations.

We will only process your personal data when we have a lawful basis to do so, including where it is necessary for our legitimate business interests, to perform a contract with you, or to comply with our legal obligations.

## **5. Data Sharing and Disclosure**

We do not sell or rent your personal data. We may share your information only with:

- Professional advisers, service providers, or contractors who assist us in operating our business and are bound by confidentiality obligations.
- Regulatory, government, or law enforcement authorities, where required by law.

All third parties are required to maintain appropriate security measures and use your personal data only in accordance with our instructions and the law.

## **6. International Transfers**

If we transfer your personal information outside the United Kingdom or the European Economic Area (“EEA”), we ensure appropriate safeguards are in place to protect it, such as using the UK’s approved Standard Contractual Clauses.

## **7. Data Retention**

We retain personal information only for as long as necessary to fulfil the purposes for which it was collected or to meet legal, regulatory, or operational requirements. Once the retention period has expired, data is securely deleted or anonymised.

## **8. Your Rights**

Under the UK GDPR, you have the right to:

- Access the personal data we hold about you.
- Request correction or deletion of your data.
- Object to processing or request restriction of processing.
- Request data portability.
- Withdraw consent (where applicable).
